		The publication reports that Treasury has abandoned its earlier promise to give power sector investors sovereign guarantees that would help unlock an estimated Sh128billion for the development of new sources of electricity. Power sector players have indicated that the withdrawal of the guarantees puts in doubt the delivery of key projects with the potential of adding 654W to the national grid.
